Description of 5.412 Acres

Description of a tract of land situate the Ohio Company Purchase Town 11, Range 14, Fraction 25, Section 20, Trimble Township, Athens County, Ohio.
Being part of the land deeded to Richard L. Dixon and Linda K. Dixon,
Official Record Book 200, pages 478-479 Second Tract, Parent Parcel M010010047800,
and being more fully described as follows:

Commencing at a concrete post at the southeast corner of said Fraction 25;

Thence N 85°20'09"W 3627.58 feet along the south boundary of Fraction 25 to an iron pin set at the southeast corner of said parcel of Dixon 200-478 Second Tract,;

Thence N85°20'09"W 362.79 feet along the boundary of the First and Second Tract of Dixon 200-478 to an iron pin set at the point of beginning of the tract herein described;

1.) Thence N85°20'09"W 474.88 feet continuing along the boundary of the First Tract and Second Tract of Dixon 200-478 to an iron pin set;

2.) Thence N28°38'50"E 895.10 feet along a common boundary to Dixon 200-478 and Miller 293-206 to a point in the center of County Road 67, Goose Rd., passing an iron pin set at 875.10 feet;

3.) Thence S50°41'51"E 243.24 feet to a point in the center of said road;

4.) Thence S32°38'28"W 271.57 feet, passing an iron pin set at 21.57 feet over the lands of Dixon 200-478 Second Tract to an iron pin set;

5.) Thence S00°19'02"E 441.40 feet over the lands of Dixon 200-478 Second Tract to the point of beginning containing a total of 5.412 acres.

Iron pins set are 30 inches length number 5 rebar capped "NEWMAN PS-8043"
