Erdy, Jr. as described in O.R. 331 on Page 661 and is situated in and being a part of Section 25 Trimble Township, Township 11 North in Range 14 West in the Ohio Company's Purchase in Athens County, Ohio and is better described as follows:

Beginning for a reference at an existing 5/8" iron pin found at the southwest Corner of the Southeast Quarter of the Southwest Quarter of Section 25;

Thence, with the east line of the United States of America parcel (D.V. 98 Pg. 852), North 2 degrees 34 minutes 48 seconds East, 235.79 feet to a point in the center of State Route 685;

Thence, with the said road, the following (4) four courses:

1.) North 56 degrees 46 minutes 00 seconds East, 191.28 feet to a point;

2.) Thence, North 65 degrees 19 minutes 08 seconds East, 188.18 feet to a point;

3.) Thence, on a curve to the left, Curve Data: Delta = 14 degrees 10 minutes 03 seconds, Radius = 603.53 feet, Arc = 149.24, North 58 degrees 14 minutes 07 seconds East, 148.86 feet along the chord to a point;

4.) Thence, North 51 degrees 09 minutes 05 seconds East, 51.57 feet to the true point of beginning;

2.) Thence, on a curve to the right, Curve Data: Delta = 22 degrees 49 minutes 57 seconds, Radius = 362.73 feet, Arc = 144.55 feet, North 62 degrees 34 minutes 03 seconds East, 143.59 feet along the chord to a point;

3.) Thence, North 73 degrees 33 minutes 36 seconds East, 271.08 feet to a point;

Thence, leaving the said road and with the west line of Grace Mingus, Etal (O.R. 528 Pg. 1417), South 4 degrees 06 minutes 26 seconds West, passing an existing 1/2" iron pin at 29.46 feet, a total distance of 440.92 feet to an existing 1/2" iron pin;

Thence, with the north line of Karen S. Scharbarth (O.R. 345 Pg. 35), South 72 degrees 28 minutes 50 seconds West, 470.70 feet to an existing 1/2" iron pin;

Thence, with the east line of Darrell J. & Anne M. Gladish (D.V. 235 Pg. 591), North 1 degree 47 minutes 55 seconds East, passing an existing 1/2" iron pin at 338.88 feet, a total distance of 373.33 feet to the true point of beginning.
