Trace and recorded in Official Record Book 533, Page 823, North 62 degrees 3 minutes 38 seconds West a distance of 137.00 feet to a point in the centerline of said Red Rock Road, taken to be in the northerly line of said 3.52 acre tract, taken to be the southeasterly corner of a 6.081 acre tract as conveyed to Brenda K. Simons, Richard L. Keith, Jr. and Gregory Allen Keith and recorded in Official Record Book 303, Page 2675;

thence leaving the centerline of said Red Rock Road and with a line taken to be the easterly line of said 6.081 acre tract for the next 2 calls:

- 1. North 35 degrees 32 minutes 1 seconds East a distance of 850.00 feet to a ½" iron pin found (no cap or tag), passing a 5/8" iron pin found (no cap or tag) at a distance of 30.00 feet;
- 2. South 62 degrees 3 minutes 38 seconds East a distance of 137.00 feet to a ½" iron pin found (no cap or tag), taken to be in the easterly line of said 6.081 acre tract, taken to be in the westerly line of said 5.58 acre tract as conveyed to Cale S. Lewis;

thence with a line taken to be the westerly line of said 5.58 acre tract, South 35 degrees 32 minutes 1 seconds West a distance of 850.00 feet to the **Point of Beginning** and containing 2.650 acres more or less, passing a 5/8" iron pin found (no cap or tag) at a distance of 820.00 feet and subject to all legal rights-of-way, restrictions, reservations, zoning regulations of record and easements of record.

All iron pins set are 5/8" steel rebar, 30 inches in length with a blue cap marked "Kinnison PS 8231".
