- 2. South 04 Degrees 09 Minutes 32 Seconds West 116.54 feet to a point;

Exline recorded in Official Record 87, Page 525, the northwest corner of Lot 1 of Pine Ridge Subdivision recorded in Slide 166 (Morgan County) conveyed to Dirk and Laurie Walton Recorded in Deed Book 203, Page 318 and the northeast corner of a 0.38 acre parcel conveyed to Gary W. Humphrey and LaVerne M. Humphrey in Deed Book 204, Page 212 (Morgan County);

Thence North 69 Degrees 41 Minutes 41 Seconds West 104.49 feet along the north line of a 0.38 acre parcel conveyed to Gary W. Humphrey and LaVerne M. Humphrey in Deed Book 204, Page 212 (Morgan County) to the **Point of Beginning**.
