DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Trimble, T-11, R-14, being a part of Paul L. & Sue A. McIntosh OR 142 Pg. 377, being part of the Northwest Quarter of Section 8, and more particularly described as follows:

Beginning at a point at the Northeast Corner of Lot 11 of the Original Plat of Trimble Plat Book 2 Pg. 40; thence along the North Line of Mill Street South 83 Degrees 48 Minutes 49 Seconds East 33.90 feet to an iron pin found; thence South 07 Degrees 03 Minutes 49 Seconds East 107.84 feet to an iron pin found; thence North 66 Degrees 59 Minutes 00 Seconds East 248.16 feet to an iron pin found; thence South 12 Degrees 00 Minutes 34 Seconds East 386.68 feet to an iron pin found; thence North 87 Degrees 26 Minutes 09 Seconds West 98.83 feet to an iron pin set and the place of beginning; thence South 02 Degrees 56 Minutes 11 Seconds West 66.06 feet to an iron pin found; thence North 07 Degrees 03 Minutes 49 Seconds West 67.00 feet to an iron pin found; thence South 87 Degrees 26 Minutes 09 Seconds East 11.63 feet to the place of beginning, containing 0.01 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the North Line of Mill Street as being South 83 Degrees 48 Minutes 49 Seconds East.




