### **ORDINANCE NO.** 7-12-10 (A)

AN ORDINANCE VACATING UN-NAMED STREET EAST OF ELM STREET AND SOUTH OF S.R. 329 IN THE VILLAGE OF TRIMBLE AND DECLARING AN EMERGENCY.

WHEREAS, the street referenced above, in the Village of Trimble as shown on Village Tax Plat

Nos. 5 and 8, Athens County Auditor's Office, is no longer being used as a public street; and

WHEREAS, the property owners on both sides of said street have petitioned and presented to Trimble Village Council, their request to vacate said street.

# NOW THEREFORE, IT IS HEREBY ORDAINED BY THE VILLAGE OF TRIMBLE, ATHENS COUNTY, OHIO, AS FOLLOWS:

- 1. Said street as shown on the attached Survey, is hereby vacated and the land contained in said street is hereby conveyed to the adjoining property owners, as shown on the attached Plats and Surveys (0.086± AC to Crystal and Dallas Chesser, husband and wife; 0.127± AC to Robert and Christina Lenigar, husband and wife; and 0.277± AC to Mark Dellinger);
- 2. The adjoining landowners take said vacated street SUBJECT TO any and all utility and other easements previously granted by the Village of Trimble, including any Sewer Easement granted to T.T.W.W.T.D., and subject to a continuing Right of Way for fire protection services.
- 3. This Ordinance is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio Rev. Code Sec. 731.30 because it is necessary for the preservation of the health, safety and welfare of the Citizens of Trimble;
- 4. Publication of this Ordinance shall be made by posting a copy of the same within at least five (5) locations within the Village.
- 5. All deliberations resulting in the passage of this Ordinance were conducted in open meetings of Council, and that all deliberations of Council that resulted in such action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code;
- 6. This Ordinance shall become effective the earliest date provided by law.


