Miller Hockingport Addition, THE TRUE POINT OF BEGINNING; thence along the south line of Lot 1193 and Lot 1192 of said Addition South 66°59'26" West 181.00 feet to a set iron pin at the southwest corner of said Lot 1192; thence along the west line of Lot 1192 North 23°00'11" West 177.76 feet to a set iron pin at the northwest corner of Lot 1192, said set iron pin is witnessed by a found, disturbed iron pin bearing South 63°35'07" East 0.63 feet; thence along the north line of said R.A. Miller Addition the following seven bearings and distances:

- 1) South 66°58'58" West 160.05 feet to a found iron pin at the northwest corner of Lot 1190; thence
- 2) South  $67^{\circ}02'12"$  West 79.95 feet to a found iron pin at the northwest corner of Lot 1189; thence

- 2) South 88°22'26" West 116.17 feet to a point at the intersection of said State Route 124 with the east right of way line of Ohio Street; thence leaving State Route 124 and along the east right of way line of Ohio Street North 07°32'02" East (passing a set iron pin at 15.00 feet) for a total distance of 634.03 feet to a set iron pin at the intersection of said east right of way line of Ohio Street with the north right of way line of Cedar Street; thence along the north right of way line of Cedar Street North 82°25'58" West (passing an iron pin\* at 66.00 feet) for a total distance of 267.47 feet to an existing fence line post at the intersection of the north right of way line of Cedar Street with the east property line of a 1.30 acre tract described in Volume 265 Page 337 of the Athens County Deed Records; thence along the east line of said 1.30 acre tract North 06°35'44" East 319.66 feet to an iron pin\* at the northeast corner of said 1.30 acre tract; thence on a random line the following four bearings and distances:

Miller Hockingport Addition at 479.29 feet, said iron pin set being witnessed by a found, disturbed iron pin bearing South 28°07'10" East 0.60 feet) for a total distance of 685.58 feet to the point of beginning and containing 26.482 acres and being a part of the tracts of lands described in Volume 21 Page 406 of the Athens County Official Deed Records, there being 0.3264 acres in Lot 1192 of the R.A. Miller Addition (eighth tract of Volume 21 Page 406 O.D.R.), 0.6258 acres in Lot 1193 of the R.A. Miller Addition (ninth tract), 3.6648 acres in 8 Acre Lot 1053 (first tract), 3.9762 acres in Lot 1054 (second tract), 4.0572 acres in Lot 1055 (third tract), 3.3625 acres in Lot 1056 (fourth tract), 2.8215 acres in Lot 1057 (fifth tract), 2.2988 acres in Lot 1058 (sixth tract), 0.4074 acres in Lot 1059 (seventh tract) and 4.9414 acres in the twelfth tract. The above described 26.482 acre tract contains 24.7299 acres in Section 1 and 1.7521 acres in Section 7.
