

SURVEYOR'S DESCRIPTION

SITUATE TOWNSHIP OF TROY, COUNTY OF ATHENS, STATE OF OHIO, 262 ACRE FRACTION 5, TOWN 5 NORTH, RANGE 11 WEST, SECTION 10, FRACTION 5

BEGINNING AT A POINT IN CENTER OF OLD ROUTE 50, SAID POINT LYING 596 FEET WESTERLY FROM THE NORTHEASTERLY CORNER OF SAID FRACTION 5 REFERENCE VOLUME 250 PAGE 183, SAID POINT ALSO BEING THE NORTHEASTERLY CORNER OF THAT SAME PROPERTY AS CONVEYED TO PATTY LOU OLLOM OF RECORD IN VOLUME 250 PAGE 183.

THENCE LEAVING SAID ROAD S 06°32'22" W PASSING THROUGH AN IRON ROD FOUND AT 20 FEET FOR A TOTAL DISTANCE OF 124 FEET TO AN IRON PIPE FOUND AND THE TRUE POINT OF BEGINNING.

THENCE CONTINUING S 06°32'22" W PASSING THROUGH AN IRON ROD SET AT 597.47 FEET FOR A TOTAL DISTANCE OF 806.70 TO A POINT LYING IN THE CENTER OF NEW ROUTE 50.

THENCE ALONG THE CENTER OF SAID ROUTE 50 FOR S 81°12'46" W ALONG THE CHORD OF A CURVE HAVING A RADIUS OF 5729.58' REFERENCE SAID BEARING TO A SURVEY BY MATTHEW B. HARPER, PS FOR TIMOTHY W. HARPER DATED 10/25/1996 FOR A CHORD DISTANCE OF 85.02' TO A POINT LYING IN THE WESTERLY LINE OF DANNY W. STUKEY, ET AL OF RECORD IN OFFICIAL RECORD BOOK 38 AT PAGE 324.

THENCE LEAVING SAID ROAD N 06°32'22" E PASSING THROUGH AN IRON ROD SET AT 208.35 FEET FOR A TOTAL DISTANCE OF 829.18 FEET TO AN IRON ROD SET AT SAID OLLOM'S SOUTHWESTERLY CORNER.

THENCE ALONG THE SOUTHERLY LINE OF SAID OLLOM S 83°27'38" E FOR A DISTANCE OF 82 FEET TO THE TRUE POINT OF BEGINNING CONTAINING A TOTAL OF 1.540 ACRES AND BEING PART OF THAT SAME PROPERTY AS CONVEYED TO ABOVE MENTIONED DANNY W. STUKEY, ET AL OF RECORD IN OFFICIAL RECORD BOOK 38 AT PAGE 324.

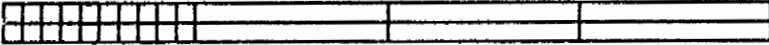
