SITUATE IN AND BEING A PART OF THE NORTH HALF OF THE SOUTHEAST QUARTER OF SECTION NUMBER 12, TOWN 5, RANGE 11, TROY TOWNSHIP, ATHENS COUNTY, OHIO, BEING MORE PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS;

BEGINNING AT A MARKED STONE FOUND, SAID MARKED STONE FOUND BEING THE CENTER OF SAID SECTION 12 AND BEING A COMMON CORNER TO THE 70.96 ACRE (TAXED) B. L. CRAIG AND MARILYN S. HOLLER TRACT (OFFICIAL RECORD 7, PAGE 604), THE 59.53 ACRE (TAXED) WENDALL B. AND W. SCOTT SINNETT TRACT (OFFICIAL RECORD 461, PAGE 1262) AND THE 23.93 ACRE (TAXED) JAMES R. AND BEVERLY PACKARD TRACT (OFFICIAL RECORD 253, PAGE 590); THENCE S 87°48'02" E 310.08 FEET, WITH THE NORTH LINE OF THE NORTH HALF OF THE SOUTHEAST QUARTER OF SAID SECTION AND SAID 70.96 ACRE (TAXED) B.
