Situated in the southeast quarter of Section 18, Town 5, Range 11, Troy Township, Athens County, Ohio and described as follows:

Commencing at a stone (calculated location) at the southeast corner of said Section 18; thence on an assumed bearing of South 89 degrees 53 minutes 44 seconds West, a distance of 2419.07 feet to a point in the center of Troy Township Road 177, THE TRUE POINT OF BEGINNING; thence continuing South 89 degrees 53 minutes 44 seconds West along said road and along the north property line of a 0.955 acre tract described in Volume 381 Page 501 of the Athens County Deed Records and the north line of a 82.29 acre tract described in Volume 87 Page 257 of the Athens County Official Deed Records, a distance of 298.31 feet to a point at the intersection of said Township Road 177 and Athens County Road 59; thence along the center of said Athens County Road 59 and the east property line of a 82.71 acre tract described in Volume 255 Page 591 of the Athens County Deed Records North 2 degrees 08 minutes 48 seconds West, a distance of 130.55 feet to a point; thence North 0 degrees 26 minutes 46 seconds West, a distance of 165.18 feet to a point; thence leaving Athens County Road 59 South 85 degrees 02 minutes 35 seconds East (passing a set iron pin at 41.42 feet) for a total distance of 191.91 feet to a set iron pin; thence South 0 degrees 51 minutes 29 seconds East, a distance of 197.93 feet to a set iron pin; thence North 89 degrees 55 minutes 09 seconds East, a distance of 105.59 feet to a set iron pin; thence South 3 degrees 21 minutes 38 seconds East (passing a set iron pin at 66.82 feet) for a total distance of 80.89 feet to the POINT OF BEGINNING and containing 1.4593 acres, and being a part of a 78.10 acre tract described in Volume 89 Page 555 of the Athens County Official Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer P.L.S. 6765. The above description was prepared under the supervision of Leonard F. Swoyer Registered Professional Land Surveyor Number 6765 and based on a field survey performed by Southeastern Land Surveys dated July 13,1998. Subject to Description checked for all easements and right of way of records.


