ommencing at the northeast corner of the southeast quarter of Section 19; thence along the north line of said southeast quarter South 88°40'51" West 643.50 feet to a found stone at the southwest corner of a 24.15 acre tract described in Volume 180 Page 522 of the Athens County Deed Records, said found stone is THE TRUE POINT OF BEGINNING; thence continuing along the north line of said southeast quarter South 88°40'51" West 431.47 feet to a set iron pin; thence along the west property line of a 40.0 acre tract described in Volume 350 Page 33 of the Athens County Deed Records South 00°14'24" East (passing a set iron pin at 825.48 feet) for a total distance of 855.48 feet to a point in the center Troy Township Road 161; thence along the center of said Troy Township Road 161 North 53°52'59" West 297.00 feet to a point; thence leaving the said road and allong the property line of a 12.50 acre tract described in Volume 362 Page 949 of the Athens County Deed Records North 00°14'24" West (passing a found iron pin at 650.49 feet) for a total distance of 674.91 feet to a set iron pin on the north line of aforesaid southeast quarter of Section 19; thence along the north line of said southeast quarter South 88°40'51" West 280.23 feet to set iron pin (witness a found iron pin North 13°09'13" East 7.82 feet); thence along the east property line of the aforementioned 12.5 acre tract North 00°14'24" West 240.90 feet to a set iron pin; thence leaving the said east property line North 89°07'03" East 949.06 feet to a set iron pin on the west property line of the aforeasaid 24.15 acre tract described in Volume 180 Page 522 of the Athens County Deed Records; thence along the west property line of said 24.15 acre tract South 00°40'22" East 233.64 feet to the point of beginning containing 9.3759 and being all of the premisies described in tract two and tract three of Volume 350 Page 33 of the Athens County Deed Records.
