DESCRIPTION OF A 0.505 ACRE PARCEL

Situated in Troy Township, Athens County, State of Ohio

Being a **0.505** acre parcel of land located in part of Section 2, Township 05 North, Range 11 West, Ohio Company Purchase, Troy Township, Athens County, State of Ohio and being a 0.71 acre parcel as conveyed to Wayne O. & Susan D. Cornell by a deed recorded in Official Records Book 437 at Page 798 of said county Deed Records and being more fully bounded and described as follows:

Beginning at an iron pin set being the southwesterly corner of said 0.71 acre parcel, the northwesterly corner of a 1.42 acre tract as conveyed to Wayne O. and Susan D. Cornell by a deed recorded in Officical Records Book 437 at Page 798 of said county Deed Records and a point on the easterly line of a 45.43 acre parcel as conveyed to Audra Burke by a deed recorded in Deed Book 154 at Page 836 of said county Deed Records, from which the northwesterly corner of 8.00 acre Lot 1032 of the Ohio Company Purchase bears S 76° 57' 34" W, being the basis of bearing for this description, 2,322.24 feet for reference;

- Course No. 1: Thence, N 20° 37' 53" E, with the easterly line of said 45.43 acre parcel, 99.91 feet to an iron pin set, being the southwesterly corner of a 0.88 acre parcel as conveyed to Danny V. Buskirk by a deed recorded in Deed Book 340 at Page 81 of said county Deed Records;
- Course No. 2: Thence, S 64° 51' 07" E, with the southerly line of said 0.88 acre parcel, passing an iron pin found (5/8") at 80.27 feet and iron pin found (3/4" Canter) at 153.97 feet for reference, a total distance of 227.66 feet to an iron pin set being the Mean High Water Line for the Ohio River Belleville Pool Mile Marker 197.25 as published by the U.S. Army Corps of Engineers;
- **Course No. 3:** Thence the following two courses and distances, with a meandering line of elevation on the Mean High Water Line to an iron pin set being a point on the northerly line of said 1.42 acre parcel;

S 31° 11' 57" W, 54.13 feet; S 18° 29' 13" W, 46.09 feet;

Course No. 4: Thence, N 64° 51' 07" W, with the northerly line of said 1.42 acre parcel, 219.44 feet to the **Point of Beginning**, containing **0.505 acres**, more or less, and being subject to all legal rights of way and easements of record.

Being subject to and having access to an ingress/egress easement, being 50 foot in width, 25 foot each side of the same location as the now vacated portion of State Route 124 and being more fully described in Official Record Book 421 at Page 2099.

All iron pins set being 5/8" x 30" rebar with plastic cap stamped "Buckley Group - 04153".
