DESCRIPTION OF SURVEY FOR JERRY SWAIN

Being a part of a 2.1215 acre± tract transferred to Jimmy A. and Kristi Swain as recorded in Official Records Volume 154 at Page 491, Athens County Recorder's Office, Athens County Ohio, also being a part of Section 31, Township-5-North, Range-11-West, Troy Township, Athens County, State of Ohio and more particularly described as follows:

Beginning at a 5/8" iron pin set on the assumed South line of said 2.1215 acre± tract which bears South 09°33'17" West a distance of 1555.99 feet, South 80°26'43" East a distance of 2950.86 feet, and South 53°07'53" East a distance of 314.28 feet from the assumed Northwest corner of said Section 31, Township-5, Range-11;

Thence leaving said South line North 46°56'34" East a distance of 127.26 feet to a 5/8" iron pin set;

Thence South 52°56'43" East passing thru an existing iron pipe at a distance of 156.79 feet and going a total distance of 186.54 feet to a point in the center-lipe of Township Road #468C;

Thence along said centerline South 37°02'55". West a distance of 124.69 feet to a point;

Thence leaving said centerline and along the assumed South line of said 2.1215 acre± tract North 53°07'53" West passing thru an existing iron pipe at a distance of 29.75 feet and going a total distance of 208.41 feet to the principal point of beginning containing 0.5667 acre± subject to all legal easements and rights-of-way.

Bearings were derived from magnetic taken October 30, 1996.
