Commencing at the southwest corner of Section 33; thence on an assumed bearing along the south line of said Section 33 South 87 degrees 33 minutes 55 seconds East, a distance of 2664.21 feet to a point on the east line of a 2.378 acre tract described as Parcel 426 WL and recorded in Volume 193 Page 719 of the Athens County Official Deed Records; thence leaving the south line of Section 33 and along the east line of said 2.378 acre tract North 1 degrees 57 minutes 03 seconds East, a distance of 49.45 feet to an iron pin* at the northeast corner of said 2.378 acre tract and the southeast corner of a 41.08 acre tract described in Volume 170 Page 148 of the Athens County Official Deed Records and on the northerly right of way line of U.S. Route 50, said iron pin* is THE TRUE POINT OF BEGINNING; thence along the northerly line of said 2.378 acre tract, the south line of said 41.08 acre tract and the northerly right of way line of U.S. Route 33 North 70 degrees 10 minutes 41 seconds West, a distance of 83.58 feet to a set iron pin; thence leaving the northerly right of way of U.S. Route 33 and along an arbitrary line the following four bearings and distances: 1) North 8 degrees 13 minutes 50 seconds West, a distance of 436.28 feet to a set iron pin; thence 2) South 86 degrees 54 minutes 10 seconds East, a distance of 147.46 feet to a set iron pin, thence 3) South 10 degrees 01 minute 39 seconds East, a distance of 366.78 feet to a set iron pin; thence 4) South 21 degrees 55 minutes 23 seconds East, a distance of 74.98 feet to a set iron pin on the aforesaid northerly right of way line of U.S. Route 50 on the northerly line of a 0.329 acre tract described as Parcel 428 WD and recorded in Volume 193 Page 695 of the Athens County Official Deed Records and on the southerly line of a tract described in Volume 195 Page 01 of the Athens County Official Deed Records, thence along the northerly right of way of U.S. Route 50 and the northerly line of said 0.329 acre tract and the south line of said tract described in Volume 195 Page 01 of the Athens County Official Deed Records South 54
