Description of 142.818 Acres

Being a new survey of several tracts as conveyed to William H. Richardson and Paul I. Richardson by Official Records Volume 440, Page 1590 of the Athens County Recorder's Office and being bounded and described as follows;

Situated in the State of Ohio, County of Athens, Township of Troy, being part in Section 36 and part in Section 30, Range 11 West, Township 5 North, of the "Ohio Company's Purchase" and being further bounded and described as follows:

Beginning at an iron pin set at the southeast corner of Section 36 (Note: Reference bearing on the south line of the southwest quarter of the southwest quarter of Section 30 used as North 86°40'04" West);
