Situated in the southeast and the southwest quarter of Section 7, Town 5, Range 11, Troy Township, Athens County, Ohio and described as follows:

Commencing at the southwest corner of an 83.463 acre tract owned by Jack and Teresa L. Fought and described in Volume 142 Page 694 of the Athens County Official Deed Records; thence along the south line of said 83.463 acre tract and the county line between Meigs and Athens County South 84 degrees 15 minutes 00 seconds East, a distance of 1374.40 feet (deed) to a point; thence along the east line of the aforesaid 83.463 acre tract North 05 degrees 14 minutes 03 seconds East, a distance of 397.09 feet to a found iron pin at the southwest corner of a 2.19 acre tract described in Volume 82 Page 957 of the Athens County Official Deed Records; thence along the west line of said 2.19 acre tract and the east line of the aforesaid 83.463 acre tract North 27 degrees 23 minutes 16 seconds West, a distance of 184.55 feet to a point, the northwest corner of said 2.19 acre tract and THE TRUE POINT OF BEGINNING; thence continuing along the east property line of the aforesaid 83.463 acre tract and the west line of a 26.4704 acre tract described in Volume 297 Page 770 of the Athens County Official Deed Records North 27 degrees 23 minutes 16 seconds West 311.35 feet to a set iron pin; thence leaving the east line of the aforesaid 83.463 acre tract and the west line of the aforesaid 26.4704 acre tract South 75 degrees 52 minutes 36 seconds East, a distance of 448.26 feet to a set iron pin; thence South 60 degrees 02 minutes 49 seconds East, a distance of 93.23 feet to a set iron pin; thence South 79 degrees 59 minutes 00 seconds East, a distance of 46.84 feet to a set iron pin; thence North 85 degrees 48 minutes 14 seconds East, a distance of 56.23 feet to a set iron pin; thence North 75 degrees 18 minutes 21 seconds East (passing a set iron pin at 150.31 feet) for a total distance of 165.12 feet to a point in the center of State Route 124; thence along the center of State Route 124 South 21 degrees 07 minutes 46 seconds West, a distance of 55.12 feet to a point; thence leaving the said State Route 124 South 71 degrees 05 minutes 47 seconds East (passing set iron pins at 12.52 feet and 53.00 feet) for a total distance of 86.03 feet to a point in the pool stage of the Ohio River; thence along said pool stage South 27 degrees 36 minutes 17 seconds West, a distance of 138.01 feet to a point, the northeast corner of the aforesaid 2.19 acre tract; thence leaving the said pool stage and along the north line of
