Thence S $43^{\circ}34'49''$ E along the existing Grantor's Northeasterly line, 42.87 feet to a point; thence N $70^{\circ}44'03''$ W along a random line, 58.75 feet to an iron pipe set in the centerline of said heretofore Un-Dedicated Extension of Campbell Street; thence N $04^{\circ}26'40''$ E along the said centerline of said heretofore Un-Dedicated Extension of Campbell Street, 15.00 feet to an iron pipe set in the Grantor's existing North line (being the same iron pipe that is referred to as having been set at 414.00 feet in the above mentioned last course getting to the point of beginning); thence S $82^{\circ}26'21''$ E along the said Grantor's North line, 24.97 feet to the point of beginning and containing 0.0174 acre.

Commencing at the Northwest corner of FR 31; thence S $01^{\circ}29'21''$ E along the West line of said FR 31, 795.63 feet to an iron pipe found in the Grantee's Northwest corner; thence S $82^{\circ}26'21''$ E along the Grantee's North line, 438.97 feet to an iron pipe set in the Grantor's most Northeasterly corner, passing through iron pipes set at 280.96 feet, 374.00 feet and at 414.00 feet (said iron pipe set at 414.00 feet being in the centerline of a heretofore Un-Dedicated Extension of Campbell Street); thence S $43^{\circ}34'49''$ E along the Northeasterly line of a 0.0174 acre NON-BUILDING SITE PARCEL to be transferred by the Grantee herein to the Grantor herein, 42.87 feet to a point in the East line of the Grantee herein and the West line of the Grantor herein, said point also being in the Southeasterly corner of said 0.0174 acre NON-BUILDING SITE PARCEL, said point also being the real point of beginning of the parcel herein described:

Thence S $70^{\circ}41'03''$ E along a Southeasterly extension of the South line of said 0.0174 acre NON-BUILDING SITE PARCEL, 116.75 feet to an iron pipe set, passing through an additional iron pipe set at 31.25 feet; thence S $42^{\circ}09'42''$ E along a random line, 162.08 feet to an iron pipe set, passing through the Southerly Corporation line of the Village of Coolville at 55.52 feet; thence S $61^{\circ}56'21''$ E along another random line, 177.13 feet to an iron pipe set; thence S $04^{\circ}43'38''$ W along another random line, 140.68 feet to an iron pipe set in the Grantee's existing Northeasterly line and the Grantor's existing Southwesterly line, said iron pipe bearing S $43^{\circ}34'49''$ W, 35.19 feet from an iron pipe set in the existing Grantee's Southeasterly corner and the Grantor's existing Southwesterly corner, said last course of the herein described parcel passing through an additional iron pipe set at 23.22 feet; thence N $43^{\circ}34'49''$ W along said Grantee's existing Northeasterly line and said Grantor's existing Southwesterly line, 527.59 feet to the point of beginning passing through the existing Southeasterly Corporation line of the Village of Coolville at 380.76 feet, and containing a total of 0.6647 acre, of which, 0.1230 acre lies in the Village of Coolville and 0.5417 acre lies in Troy Township.


