

PROPERTY DESCRIPTION 18.973 ACRE TRACT TROY TOWNSHIP, TAX PARCELS: L010010061200 & L010010061300 OFFICIAL RECORD 416, PAGE 1474

SITUATE IN AND BEING A PART OF SECTIONS 11 AND 17, TOWN 5, RANGE 11, TROY TOWNSHIP, ATHENS COUNTY, OHIO, AND BEING MORE PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT A CALCULATED POINT AT THE SOUTHWEST CORNER OF SECTION 11, TOWN 5, RANGE 11, SAID POINT ALSO BEING A COMMON CORNER TO THE 19.57 ACRE (TAXED) AND TO THE 30.18 ACRE (TAXED) DAWN SMITH-HALL TRACTS (OFFICIAL RECORD 598, PAGE 703);

THENCE N 87°24'36" W 244.20 FEET, WITH THE SOUTH LINE OF SECTION 17, TOWN 5, RANGE 11 AND SAID 19.57 ACRE DAWN SMITH-HALL TRACT, TO A 5/8" CAPPED IRON REBAR (FOUND) AT A COMMON CORNER TO THE 10.10 ACRE (TAXED) MATTHEW W. TAYLOR TRACT (OFFICIAL RECORD 547, PAGE 1693);

THENCE N 03°44'21" E 230.23 FEET, LEAVING THE SECTION LINE WITH SAID 10.10 ACRE MATTHEW W. TAYLOR TRACT, TO A 5/8" CAPPED IRON REBAR FOUND AT A COMMON CORNER TO THE 26.60 ACRE (TAXED) DANIEL D. ADAMS TRACT (OFFICIAL RECORD 550, PAGE 848);

THENCE N 02°49'29" E **485.97 FEET**, WITH SAID 26.60 ACRE DANIEL D. ADAMS TRACT, TO A 5/8" CAPPED IRON REBAR SET IN THE SOUTH LINE OF THE 28.997 ACRE (TAXED) ATHENS COUNTY BOARD OF COMMISSIONERS TRACT (OFFICIAL RECORD 512, PAGE 2457);
