- 3. South 78°34'08" East passing thru a 5/8" iron pin set at a distance of 158.85 feet and going a total distance of 188.85 feet to a point in the centerline of County Road 59, Four Mile Creek Road;

- 13. North 58°04'44" West, a distance of 57.30 feet to a point;
- 14. North 76°06'24" West, a distance of 49.66 feet to a point;
- 15. North 86°39'01" West, a distance of 159.71 feet to the point of beginning containing 9.512 acres more or less subject to all legal easements and rights of way.
