Thence leaving said Scott A. Steele corner and along the boundary of tracts transferred to Carol Simpson as recorded in Official Records Volume 578 at page 882, the following two courses;

- 1. North 90°00'00" West a distance of 82.50 feet to a 5/8" iron pin set;
- 2. North 00°30'57" East a distance of 12.63 feet to a 5/8" iron pin set being a point in the centerline of an old road;

Thence continuing along said Simpson boundary also being the centerline of an old road the following two courses;

- 1. North 65°17'14" West a distance of 194.14 feet to a 5/8" iron pin set;
- 2. North 78°48'23" West a distance of 133.92 feet to a 5/8" iron pin set;

Thence leaving said Simpson boundary and thru the lands of the grantor North 00°28'38" East passing a 5/8" iron pin set at a distance of 1130.20 feet and going a total distance of 1150.20 feet to a point in the centerline of Township Road 159 (W. Hornsby Road);
