Situated in Fraction 5 of Section 10, Town 11, Range 15, Waterloo Township, Athens County, Ohio and described as follows:

Commencing at a found stone at the southeast corner of Fraction 5; thence along the south line of said Fraction 5 on an assumed bearing of South 89°37'59" West 315.49 feet to a found stone and the TRUE POINT OF BEGINNING; thence continuing along the south line of said Fraction 5 South 89°37'59" West 284.37 feet to a point in the center of Athens County Road 100; thence along the said Athens County Road 100 North 61°24'51" West 215.98 feet to a point; thence North 66°11' 00" West 171.75 feet to a point on the east line of a 20.93 acre tract described in Volume 358 Page 303 of the Athens County Deed Records; thence leaving the said Athens County Road 100 and along the said 20.93 acre tract North 00°12'35" East (passing found iron pins at 176.62 feet, 350.97 feet and a calculated iron pin at 1164.05 feet) for a total distance of 1,216.30 feet to a calculted iron pin at the northeast corner of aforesaid 20.93 acre tract; thence along the south line of a 31.0 acre tract described in Volume 309 Page 921 of the Athens County Deed Records North 88°39'43" East 622.00 feet to a point on the west line of a 12.14 acre tract described in Volume 277 Page 209 of the Athens County Deed Records; thence along the west line of said 12.14 acre tract South 00°11'54" East (passing a set iron pin at 5.71 feet) for a total distance of 1401.70 feet to the point of beginning containing 19.361 acres and being the remainder of a 50 acre tract described as tract 1 in Volume 356 Page 309 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch in diameter and 30 inches in length and capped with a plastic identification marker scribed Leonard F. Swoyer R.L.S. 6765.


