Commencing at the northwest corner of said Section 15; thence on an assumed bearing along the north line of said Section 15 South 85°24'24" East 763.09 feet to a found iron pin; thence South 03°38'53" West 1,306.18 feet to a set iron pin on the east line of a 19.51 acre tract described in Volume 345 Page 617 of the Athens County Deed Records, said set iron pin is THE TRUE POINT OF BEGINNING; thence leaving the east line of said 19.51 acre tract South 71°33'40" East 788.11 feet to a set iron pin; thence South 03°32'43" West (passing a set wooden lath at 381.98 feet and a set iron pin at 839.11 feet) for a total distance of 859.11 feet to a point in the center of State Route 56; thence along the center of said State Route 56 North 71°23'49" West 401.68 feet to a point; thence North 71°31'12" West 150.45 feet to a point; thence North 69°48'26" West 239.95 feet to a point; thence leaving the center of said State Route 56 North 03°38'53" East (passing a set iron pin at 20.00 feet) for a total distance of 849.81 feet to the point of beginning containing 15.00 acres and being a part of a tract described in Volume 331 Page 337 of the Athens County Deed Records.
