DESCRIPTION OF A 1.012 ACRE TRACT

Situated in inlot 69, Village of New Marshfield, Fraction 1, Section 15, Town 11, Range 15, Waterloo Township, Athens County, Ohio, and being a part of a 1.94 acre tract described in Volume 383 Page 263 Athens County Deed Records and being more particularly described as follows:

Commencing at a 5/8-inch iron pin found at the Southwest corner of inlot 69 in the Village of New Marshfield;

thence, following the West line of said inlot 69, North 0 degrees 53 minutes 36 seconds East, a distance of 45.91 feet to an iron pin set, said iron pin set being the POINT OF BEGINNING of the following described tract:

thence, continuing along said line, North 0 degrees 53 minutes 36 seconds East along said line, a distance of 289.18 feet to a 5/8-inch iron pin found;

thence, leaving said West line and following the North line of said tract, South 88 degrees 54 minutes 45 seconds East, a distance of 129.00 feet to an iron pin set; thence, leaving said North line on a random line, South 0 degrees 53 minutes 36 seconds West, a distance of 271.01 feet to an iron pin set;

thence, South 61 degrees 24 minutes 20 seconds East, a distance of 28.32 feet to an iron pin set;

thence, North 87 degrees 02 minutes 21 seconds East, a distance of 120.38 feet to an iron pin set;

thence, South 1 degree 42 minutes 10 seconds West, a distance of 40.13 feet to a point on the West line of a 12.21 feet right-of-way and on the South line of the aforementioned inlot 69, passing a point on the Northwestern corner of said 12.21 feet right-of-way at 27.92 feet;

thence, following the South line of said inlot 69, South 87 degrees 02 minutes 21 seconds West, a distance of 128.42 feet to an iron pin set by a bent iron pin found at the Eastern most corner of a 0.1 acre tract described in Volume 12 Page 613 Official Records of Athens County, passing an iron pin set at 20.00 feet;

thence, leaving said South line of said inlot 69 and following the North line of said 0.1 acre tract, North 61 degrees 24 minutes 20 seconds West, a distance of 67.47 feet to an iron pin set by a bent iron pin found;

thence, North 85 degrees 56 minutes 25 seconds West, a distance of 85.89 feet to the POINT OF BEGINNING; said described tract containing 1.012 acres (44,090.1767 square feet).

Bearings are assumed and are used to denote angles only.

Subject to all easements and right-of-way of record.

All iron pins set are 5/8 inch by 30-inch long rebar with a yellow cap stamped Alan Robinson RLS 8049.
