Commencing at a railroad spike (calculated location) at the northeast corner of said Fraction 1; thence on an assumed bearing of South 77°04'37" "West 2,242.72 feet to a set railroad spike in the centerline of Athens County Road 6, said set railroad spike is the northeast corner of the tract to be described and THE TRUE POINT OF BEGINNING; thence South 11°23'47" West (passing a set iron pin at 100.42 feet) for a total distance now of 206.19 feet to a set iron pin on the north right of way line of the B.&O. Railroad; thence along said railroad right of way on a curve to the right 487.33 feet to a set iron pin, said curve has a radius of 2,789.93 feet and a chord which bears North 68°11'24" West 486.71 feet; thence North 06°08'19" East along the east line of a 71.80 acre tract described in Volume 238 Page 86 of the Athens County Deed Records (passing a set iron pin at 87.23 feet) for a total distance of 102.23 feet to a point in the centerline of the aforesaid Athens County Road 6; thence along the centerline of said road the following three bearings and distances:

- 1) South 80°25'04" East 200.55 feet to a point; thence
- 2) South 80°00'38" East 106.93 feet to a point; thence
- 3) South 80°57'38" East 180.88 feet to the point of beginning containing 1.7784 acres and being part of the first tract of lands conveyed in deed Volume 282 Page 661 of the Athens County Deed Records.

Commencing at a railroad spike (calculated location) at the northeast corner of said Fraction 1; thence on an assumed bearing South 71°52'07" West 1,602.33 feet to a found railroad spike in the centerline of Athens County Road 6 at the northwest corner of a 2.46 acre tract described in Volume 379 Page 581 of the Athens County Deed Records, said found railroad spike is THE TRUE POINT OF BEGINNING; thence leaving said county road and along the west line of said 2.46 acre tract South 03°15'22" West 30.02 feet to a found 3/4 inch rebar; thence continuing along said west property line South 03°08'31' West 304.08 feet to a found fence post corner on the north right of way line of the B.& O. Railroad; thence along said right of way on a curve to the right 283.63 feet to a set iron pin, said curve has a radius of 2,924.42 feet and a chord which bears North 84°13'22" West 283.52 feet; thence leaving said right of way North 02°03'27" East (passing a set iron pin at 269.35 feet) for a total distance of 281.35 feet to a set P.K. nail in the centerline of said Athens County Road 6; thence along the centerline of said county road the following two bearings and distances:

- 1) North 86°07'45" East 110.24 feet to a point; thence
