Situated in Fraction 36, Section 15, Town 11, Range 15, Waterloo Township, Athens County, Ohio and described as follows:

Commencing at the northeast corner of Fraction 36; thence along the east line of Fraction 36 on an assumed bearing South 03°32'44" West 3,723.06 feet to a point on the grantor's southeast property corner, said point is witnessed by a fence corner post* which bears South 14°15'06" West 3.36 feet and said point is THE TRUE POINT OF BEGINNING; thence along the grantor's south property line South 84°55'21" West 245.25 feet to an iron pin* at the southeast corner of a 5.00 acre tract described in Volume 81 Page 217 of the Athens County Official Deed Records; thence along the east line of said 5.00 acre tract North 29°34'15" West 390.12 feet to an iron pin* at the northeast corner of said 5.00 acre tract; thence along the north line of said tract South 76°13'28" West (passing a found iron pin at 649.58 feet) for a total distance of 685.08 feet to a railroad spike* in Athens County Road 6; thence along said road North 26°04'11" West 254.83 feet to a point; thence leaving said road on a random line the following two bearings and distances:

- 1) North $54^{\circ}06'17"$ East (passing a set iron pin at 14.06 feet) for a total distance of 530.01 feet to a set iron pin; thence
- 2) North 35°53'43" West 668.95 feet to a set iron pin on the south line of a 5.04 acre tract described in Volume 65 Page 975 of the Athens County Official Deed Records; thence along the south line of said 5.04 acre tract North 68°10'39" East (passing an iron pin* at 508.67 feet) for a total distance of 542.67 feet to a point in State Route 56 at the northeast corner of said 5.04 acre tract and the southwest corner of a 15.00 acre tract described in Volume 61 Page 820 of the Athens County Official Deed Records; thence along said road and along the south line of said 15.00 acre tract the following four bearings and distances:
- 1) South 71°23'48" East 11.94 feet to a point; thence
- 2) South 71°19'44" East 361.27 feet to a point; thence
- 3) South 71°49'05" East 232.14" feet to a State Highway Monument Box*; thence Description regression


