Commencing at a the northeast corner of aforesaid Section 2; thence on an assumed bearing along the north of said Section 2 North 89°20'56" West (passing a found iron pin at 357.56 feet) for a total distance of 440.56 feet to THE TRUE POINT OF BEGINNING, said found iron pin is also the northwest corner of a 5.00 acre tract described in Volume 384 Page 461 of the Athens County Deed Records; thence along the west property line of said 5.00 acre tract South 00°46'59 " West (passing a found iron pin at 277.81 feet) for a total distance of 490.69 feet to a found iron pin at the northeast corner of a 5.4083 acre tract; thence along the north property line of said 5.4083 acre tract North 88°27'05" West 635.39 feet to a found iron pin; thence continuing along the north line of said 5.4083 acre tract South 70°26'21" West (passing a found iron pin at 233.22 feet) for a total distance of 250.92 feet to a point in the center of Waterloo Township Road 27; thence along said Township Road 27 the following three courses: 1. North 26°11'53" West 236.96 feet to a found iron pin, the southeast corner of a 2.59 acre tract described in Volume 331 Page 39 of the Athens County Deed Records; thence along the easterly property line of said 2.59 acre tract 26°30'42" West 275.07 feet to a found iron pin the northeast corner of said ... 2.59 acre tract; thence 3. North 26°34'24" West 125.15 feet to a found iron pin on the north line of aforementioned Section 2, said found iron pin is the northeast corner of a 2.16 acre tract described in Volume 205 Page 373 of the Athens County Deed Records; thence leaving the aforementioned Waterloo Township Road 27 and along the north line of aforementioned Section 2 South 89°20'56" East (passing set iron pins at 16.87 feet, 430.52 feet and 697.88 feet) for a total distance of 1,161.74 feet to the point of beginning containing \$2044 acres and being part of a 40 acre tract described in Volume 344 Page 903 of the Athens County Deed Records

Note: All set iron pins are capped 5/8 inch diameter rebar 30 inches in length. 27


