DESCRIPTION OF A 5.00 ACRE TRACT

Commencing at the North-west corner of Fraction 25, thence, South 00 Degrees 40 Minutes East, 330 feet (deed) to a stone at the North-west corner of the Wells 5 acre tract; thence, South 00 Degrees 40 Minutes East, 450.04 feet to a point in County Road 8; thence, along said road, South 75 Degrees 38 Minutes East, 478.40 feet to a point; thence, South 79 Degrees 17 Minutes 28 Seconds East, 178.39 feet to a railroad spike set, said spike being the point of beginning for the tract of land herein described:

Thence, continuing along said road, South 58 Degrees 32 Minutes 23 Seconds East, 108.55 feet to a railroad spike set; thence, leaving said road, North 58 Degrees 29 Minutes 32 Seconds East, 346.77 feet to an iron pin set, passing an iron pins set at 45.02 feet and 252.21 feet; thence, North 63 Degrees 20 Minutes 58 Seconds East, 240.79 feet to an iron pin set; thence, North 35 Degrees 19 Minutes 28 Seconds West, 97.68 feet to an iron pin set; thence, North 48 Degrees 17 Minutes 31 Seconds West, 205.24 feet to an iron pin set; thence, North 77 Degrees 10 Minutes West, 112.60 feet to an iron pin set near a utility pole; thence, South 78 Degrees 08 Minutes 32 Seconds West, 201.90 feet to an iron pin set; thence, South 78 Degrees 41 Minutes 11 Seconds West, 153.08 feet to an iron pin set; thence, South 09 degrees 00 Minutes 10 Seconds East, 407.34 feet to the point of beginning and containing 5.00 acres, of which 0.30 acres are out of Tact One and 4.7 acres are out of Tract Two.
