thence South 0 degrees 14 minutes 00 seconds West a distance of 117.81 feet to a 5/8" iron pin set;

thence South 55 degrees 03 minutes 09 seconds West a distance of 284.44 feet to a 5/8" iron pin set;

thence South 83 degrees 45 minutes 50 seconds West a distance of 504.00 feet to a 5/8" iron pin set;

thence South 68 degrees 14 minutes 21 seconds West a distance of 410.99 feet to a PK nail previously set in the center of State Route 56 and passing a 5/8" iron pin set at a distance of 390.99 feet; thence with the center of State Route 56 the following five bearings and distances:

- 1) North 18 degrees 56 minutes 41 seconds West a distance of 28.92 feet to a PK nail previously set;
- 2) North 14 degrees 28 minutes 21 seconds West a distance of 67.57 feet to a PK nail previously set;
- 3) North 11 degrees 00 minutes 13 seconds West a distance of 84.51 feet to a PK nail previously set;
- 4) North 12 degrees 08 minutes 45 seconds West a distance of 71.86 feet to a PK nail previously set;
- 5) North 14 degrees 54 minutes 25 seconds West a distance of 2.88 feet to a MAG nail set; thence leaving the center of State Route 56 North 81 degrees 28 minutes 25 seconds East a distance of 690.72 feet to a 5/8" iron pin set and passing a 5/8" iron pin set at a distance of 20.00 feet;

thence North 74 degrees 27 minutes 38 seconds East a distance of 510.19 feet to the point of beginning, containing 5.000 acres more or less, subject to the public easement of State Route 56 and any other public or private easements of record.


