

EXHIBIT "A" 43.112 Acre Tract

- I) Being part of the 1st Tract of real estate owned by J & R Galvin, Ltd. as recorded in Official Record 436 at page 2021 in the Athens County Recorder's Office, Athens County, OH, and, being situate in FR. 1 (Sections 15 & 14), Town-11-North, Range-15-West, Waterloo Township, Athens County, State of Ohio, USA, and being more particularly described as follows:
- 2) COMMENCING at an iron pin found in the Northeast corner of FR. 31 (Section 21), said iron pin found also being in one of the Grantors' eight (8) existing Southwesterly property corners:
- Thence S 60°36'09" E along a random tie line, 675.66 feet to a point in another of the Grantors' eight (8) existing Southwesterly property corners and the survey centerline of Mineral Road (Co.Rd.No.8), said point also being the real **POINT OF**BEGINNING of the 43.112 Acre Tract herein described:

Markins (OR.415/Pg.2011), passing through an iron pin w/cap set in the Northwest property corner of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134) at 83.72 feet:

- S 81°17'21" E, 182.62 feet to a point in another of the Grantors' Northeasterly property corners, the Southeast property corner of said 11.517 acre tract(by deed) owned by Brian E. & Jessica A. Markins (OR.415/Pg.2011), the Southwest property corner of a tract owned by Susan A. Douglas (OR.364/Pg.758), and, the Northwest property corner of a 1.778 acre parcel (by deed) owned by Rhonda Moore, etal (OR.445/Pg.482):
- 7) Thence S 04°39'57" W along one of the Grantors' East property lines, the West property line of said 1.778 acre parcel (by deed) owned by Rhonda Moore, etal (OR.445/Pg.482), 126.71 feet to a point in another of the Grantors' Northeasterly property corners and the Northerly property line of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), passing through a 5/8" iron pin found at 15.28 feet:
- Thence along another of the Grantors' Northeasterly property lines and the Northerly property line of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), along and with the arc of a non-tangent curve to the RIGHT, an Arc distance of 439.34 feet to an iron pin w/cap set in said Northwest property corner of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), said curve having a Radius of 2,814.79 feet, a Delta of 08°56'35", the long Chord of which, bears N 63°01'22" W, 438.90 feet to said iron pin w/cap set:
- Thence S 31°24'32" W along another of the Grantors' Northeasterly property lines and the West property line of the said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), 130.00 feet to an iron pin w/cap set in another of the Grantors' Northeasterly property corners and the Southwest property corner of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), passing through a point in the said survey centerline of Mineral Road (Co.Rd.No.8) at 83.72 feet:
- Thence along another of the Grantors' Northeasterly property lines and the Southerly property line of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), along and with the arc of a non-tangent curve to the LEFT, an Arc distance of 501.29 feet to an iron pin w/cap set in another of the Grantors' Northeasterly property corners and the Northwest property corner of tract owned by Donald S. Shingler (OR.191/Pg.762), said curve having a Radius of 2,944.79 feet, a Delta of 09°45'12", the long Chord of which, bears S 63°25'47" E, 500.68 feet to said iron pin w/cap set:

- Thence S 04°39'57" W along another of the Grantors' East property lines and the West property line of said tract owned by Donald S. Shingler (OR.191/Pg.762), 822.21 feet to a 1" solid iron bar found in the Grantors' Southeast property corner and the Northeast property corner of one of the tracts owned by Charles C. & Kathleen Llewellyn (OR.19/Pg.656), passing through a 1" solid iron bar found at 236.55 feet:
- Thence N 86°57'13" W along the Grantors' South property line and the North property line of said tract owned by Charles C. & Kathleen Llewellyn (OR.19/Pg.656), 1,824.95 feet to an iron pin w/cap stamped "Price PS8362" found in another of the Grantors' eight (8) Southwest property corners and another of the property corners of said tracts owned by Charles C. & Kathleen Llewellyn (OR.19/Pg.656):
- Thence N 02°39'16" E along one of the Grantors' Southwesterly property lines and an Easterly property line of one of the said tracts owned by Charles C. & Kathleen Llewellyn (OR.19/Pg.656), 1,189.59 feet to the **point of beginning**, passing through a 5/8" iron pin found at 1,161.57 feet, and, **containing a total of 43.112 Acres**, of which, 42.386 Acres lies South of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134), and 0.726 Acre lie North of said residue old railroad tract owned by CSX Transportation (DB.203/Pg.134).
- The above described 43.112 Acre Tract comes entirely out of existing Auditor's Parcel No. No10010019700.
- 15) The above survey is based upon, and part of, a heretofore unrecorded 120.632 Acre boundary survey performed by Robert A. Price, P.S. 8362 in November, 2009 for the Grantors herein.
- 16) The bearings used in the above description are based on the South line of FR.36 (Section 15) as bearing: N 85°39'22" W, and, are only for the determination of relative angles.
- 17) Subject to all legal highways and easements.

- 18) All iron pins w/cap set referred to in the description above are 5/8" x 30" iron pins with 1-3/8" diameter plastic I.D. caps stamped "G.W. BAYHA P.S.6139 740-593-5686".
