

5.0004 ACRES +/- OR 217,816 Sq. Ft.

BEING A SURVEY OF PART OF A PARCEL CONVEYED TO NEWTON E. AND CAROLYN K. ICE AS FOUND IN DEED VOLUME 345 PAGE 883, IN THE ATHEN'S COUNTY RECORDER'S OFFICE AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

SITUATED THE STATE OF OHIO, COUNTY OF ATHENS, AND IN THE TOWNSHIP OF WATERLOO, BEING A PART OF SECTION #20, AND BEING A PART OF FRACTION LOT #25, TOWNSHIP-11, RANGE-15, OF THE OHIO PART OF FRACTION LOT #25, TOWNSHIP-11, RANGE-15, OF THE OHIO COMPANY'S PURCHASE AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING, FOR REFERENCE, AT AN IRON PIN FOUND MARKING THE SOUTHEAST CORNER OF FRACTION LOT \$25, SAID POINT BEING ON THE LINE BETWEEN SECTION #20 AND SECTION #14, THENCE WITH THE EAST LINE OF SECTION #20 N 04700'25" E 454.43 FEET TO AN IRON PIN SET AND BEING THE SOUTHEAST CORNER AND THE PRINCIPLE PLACE BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED:

THENCE, WITH WHAT REPRESENTS A NEW LINE THROUGH THE ICE PARCEL N  $85^{\circ}59^{\circ}35''$  W 732.00 FEET TO A POINT IN THE CENTERLINE OF ROUND HOUSE ROAD (TWP. RD. #24), PASSING OVER AN IRON PIN SET AT 706.17 PEET:

THENCE, WITH THE CENTERLINE OF SAID ROAD N 10°33'03" W 281.10 FEET TO A POINT IN THE SOUTH LINE OF A PARCEL CONVEYED TO ROSE L. ADAMS AS FOUND IN DEED VOLUME 376 PAGE 29:

THENCE, WITH THE SOUTH LINE OF THE ADAMS PARCEL, S 87°36'04" E 802.97 FEET TO AN IRON PIN FOUND IN THE EAST LINE OF SECTION #20, PASSING OVER AN IRON PIN FOUND AT 20.20 FEET:

CONTINUING WITH THE EAST LINE OF SECTION 04°00'25" W 294.61 FEET TO THE PLACE OF BEGINNING. THE PARCEL AS SURVEYED CONTAINS 5.0004 ACRES MORE OR LESS, SUBJECT TO ALL LEGAL EASEMENTS AND RIGHT-OF-WAYS OF RECORD.

Ice, with tax mailing address at 7548 Round House Road, Athens, OH 45701 the following described real estate situated in Waterloo Township, Athens County, Ohio, and further bounded and described as follows:

Being a survey of part of a parcel conveyed to Newton E. and Carolyn K. Ice as found in deed volume 345, Page 883, in the Athens's County Recorder's Office and being more particularly described as follows:

Situated in the State of Ohio, County of Athens, and in the Township of Waterloo, being a part of Section #20, and being a part of Fraction Lot #25, Township-11, Range 15, of the Ohio Company's purchase and being more particularly described as follows:

Beginning, for reference, at an iron pin found marking the southeast corner of Fraction Lot #25, said point being on the line between Section #20 and Section #14, thence with the east line of Section #20 North 04° 00′ 25" East 454.43 feet to an iron pin set and being the southeast corner and the principle place of beginning of the tract herein to be described:

Thence, with what represents a new line through the Ice parcel North 85° 59' 35" West 732.00 feet to a point in the centerline of Round House Road (Twp. Rd. #24), passing over an iron pin set at 706.17 feet:

Thence, with the centerline of said road North 10° 33′ 03" West 281.10 feet to a point in the south line of a parcel conveyed to Rose L. Adams as found in Deed Volume 376, Page 29:

Thence, with the south line of the Adams parcel, South 87° 36' 04" East 802.97 feet to an iron pin found in the east line of section #20, passing over an iron pin found at 20.20 feet:
