On this 7th day of May, 1999, the following is a Legal Description of a 17.081 Acre Parcel of Land located in the southwest corner of County Road No. 8 and Roundhouse Road. Beginning at the northwest corner of the east half of Fraction No. 31, Section No. 21, Town No. 11, Range No. 15, Waterloo Township, Anthens County, Ohio;

Thence South along the west line of Fraction No. 31, a distance of 931.74 feet, to a point on the centerline of County Road No. 8;

Thence S.66°11'00"E. along the centerline of said County Road No. 8, a distance of 826.00 feet, to a point, said point being the intersection of centerlines of said County Road No. 8 and Roundhouse Road;
