Situated in the northeast quarter of Section 23, Town 11, Range 15, Waterloo Township, Athens County, State of Ohio and described as follows:

Commencing at the northeast corner of said Section 23; thence along the north line of said Section 23 on an assumed bearing of South 90 degrees 00 minutes 00.0 seconds West, a distance of 1100.220 feet; thence leaving the north line of said Section 23 South 0 degrees 59 minutes 00.0 seconds West, a distance of 869.280 feet to the north east corner of a 30.36 acre tract described in Volume 279 Page 397 of the Athens County Deed Records; thence along the north line of said 30.36 acre tract South 86 degrees 13 minutes 00.0 seconds West, a distance of 812,400 feet to a found 3/4 inch square iron pin, the TRUE POINT OF BEGINNING; thence leaving the north line of said 30.36 acre tract on a random line South 2 degrees 16 minutes 22.3 seconds West (passing set iron pins at 115.00 feet and 265.00 feet) for a total distance of 364.057 feet to a set iron pin; thence on a random line South 62 degrees 47 minutes 45.6 seconds West (passing set iron pins at 145.92 feet and 275.92 feet and 375.92 feet) for a total distance of 415.597 feet to a point in the center of Waterloo Township Road 262; thence along the center of said Waterloo Township Road 262 North 3 degrees 46 minutes 42.7 seconds East, a distance of 170.458 feet; thence North 10 degrees 41 minutes 14.9 seconds East, a distance of 364.828 feet to a found railroad spike at the southwest corner of a 13.40 acre tract described in Volume 383 Page 587 of the Athens County Deed Records; thence leaving the said Waterloo Township Road 262 and along the south property line of said 13.40 acre tract North 85 degrees 17 minutes 00.5 seconds East (passing a found 3/4 inch square iron pin at 24.40 feet) for a total a distance of 306.209 feet to the point of beginning; said described tract containing 3.4265 acres and being a part of a 30.3615 acre tract described in Volume 279 Page 397 of the Athens County Deed Records.


