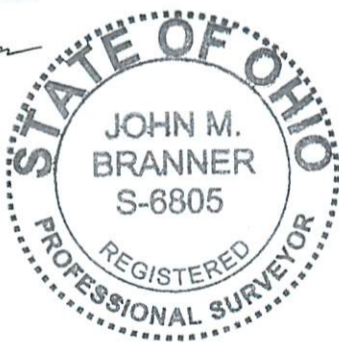

Commencing at an iron pin set at the Northeast corner of the Southeast Quarter of Section 26, thence N 86° 22' 53" W, 594.00 feet to a point; thence S 00° 57' 53" W, 333.23 feet to a point at the Southeast corner of Parcel N010010023700, Sheppard (577-545 O.R.) and also being **the Point of Beginning** for the tract of land herein described:

Thence along the East line of Sheppard (577-545 O.R.),
S 00° 57' 53" W, 84.25 feet to a point;
Thence along the line of Brooks (353-663 O.R.),
N 89° 02' 25" W, 417.48 feet to a point in State Route 356;
Thence along said road,
N 02° 10' 45" W, 81.87 feet to a point;
Thence along a new line created by this survey,
S 89° 22' 48" E, 421.98 feet to the Point of Beginning, passing an iron pin set at 75.00 feet and **containing 0.800 acres**, which is to be continuous and contiguous with N010010023800, Brooks (353-663 O.R.).
