

Description of a parcel of land situate Ohio Company Purchase, Town 12, Range 15, York Township, Fraction 1, (Section 15), Athens County, Ohio.

Being part of the lands deeded to Velma G. Woody of Official Record Book 190, pages 88-91 of the Second Tract.

Commencing at a notched stone found at the southwest corner of River Lot 608; Thence N02°49'28"E 574.28 feet to a point in a small creek, passing an iron pin set at 435.00 feet; Thence N87°10'32"W 231.22 feet to a point in said creek, and being the point of beginning of the tract herein described;

- 1.) Thence N87°10'32"W 100.32 feet along the south line of the Second Tract of Woody 190-88 to a point in said creek;
- 2.) Thence N01°44'15"W 626.56 feet along a common boundary to Woody190-88, Thompson 276-1309, and the United States 283-415 to an iron pin set on the north line of Fraction 1, passing an iron pin set at 84.53 feet, and passing an iron pin found at 498.69 feet;
- 3.) Thence S87°27'38"E 100.28 feet along a common boundary to Woody 190-88, and the United States of America 382-807 to a point on the north line of Fraction 1;
- 4.) Thence S01°44'15"E 627.06 feet, over the lands of Woody 190-88, Second Tract, passing iron pins set at 47.18 feet, and 509.49 feet, to the point of beginning containing a total of 1.439 acres.

Survey of the above 1.439 acres is to be held continuous and contiguous with the Velma G. Woody parcel referenced in Official Record Book 190, pages 88-91 as the Sixth Tract. 190-88.


