

I'm sorry this letter is late in getting to you but I just received the necessary language from Mr. Bayha, an Ex-Officio member of the Regional Planning Commission. The language which must be included in the deed is as follows:

The residue acreage of approximately 0.885 acre remaining from an existing 1.54 acre parcel owned by Frank R. and Imogene North, currently held by Deed Book 275, Page 516, after the disposal of the above described 0.655 acre parcel, is to be held in continguous and continuous ownership for all time with an existing 5.0 acre tract owned by Frank R. and Imogene North currently held by Deed Book 283, Page 72, and is to never be disposed of as a separate parcel of land by the current, and/or any future owners of the above described 5.0 acre tract and the adjacent 0.885 acre residue parcel.
