

DESCRIPTION - TRACT No. 1

0.298 ACRES

Situated in the City of Nelsonville, Township of York, County of Athens, State of Ohio and being a part of River Lot 633, Section 17, Town 12, Range 15, more particularly described as follows:

Commencing at a concrete monument found in the northwesterly line of the Roy W. Graham 1.0 acre tract recorded in Volume 298, Page 193, Athens County Recorders Office and at a corner of parcel No. 16 in a deed from The Greendale Mineral Co. to The United States of America recorded in Volume 160 Page 321, Athens County Recorders Office; thence north $45^{\circ}37'00''$ west 49.35 feet to an iron pin set, said iron pin being the place of beginning for the tract of land herein described; thence south $44^{\circ}44'24''$ west 273.06 feet to a point in U.S. Route 33, passing through an iron pin set at 270.36 feet; thence north $45^{\circ}00'00''$ west, along U.S. Route 33, 45.72 feet to a point; thence north $43^{\circ}58'28''$ east 272.57 feet to an iron pin set, passing through an iron pin set at 2.70 feet; thence south $45^{\circ}37'00''$ east 49.35 feet to the place of beginning and containing 0.298 acres.
