

thence with the North line of said Lot 35 South 74 degrees 56 minutes 00 seconds West a distance of 65.00 feet to a point in concrete steps at the Northwest corner of said Lot 35 and the Northeast corner of 34;

thence with the North line of said Lot 34 South 70 degrees 56 minutes 00 seconds West a distance of 21.89 feet to a 5/8" iron pin set;

thence South 4 degrees 56 minutes 30 seconds West a distance of 85.90

feet to a 5/8" iron pin set on the South line of said Lot 34; thence with the South line of said Lot 34 South 69 degrees 28 minutes 00 seconds East a distance of 20.76 feet to a 5/8" iron pin set at

Southeast corner of said Lot 34 and the Southwest corner of said Lot 35; thence with the South line of said Lot 35 South 69 degrees 28 minutes 00 seconds East a distance of 62.00 feet to a 5/8" iron pin set at the Southeast corner of said Lot 35 on the West line of said lot 70;

thence with the West line of said Lot 70 South 5 degrees 30 00 seconds West a distance of 52.70 feet to a 5/8" iron pin set at the Southwest corner of said Lot 70; thence with the South line of said Lot 70 South 56 degrees 42 minutes

00 seconds Fast a distance of 212.20 feet to a 5/8" iron pin set Southeast corner of said Lot 70;

thence with the East line of said Lot 70 North 3 degrees 17 minutes 00 seconds East a distance of 334.20 feet to the point of beginning containing 1.299 acres more or less, subject to any public and private easements of record
