Commencing for reference at a 5/8" iron pin previously set at the Northeast corner of Lot 70 of the Ashford Poston's Addition to the Village (now City) of Nelsonville; thence with the East line of the City of Nelsonville and the East line of Lots 71, 72, 73, and 76 of said Poston's Addition North 0 degrees 15 minutes 48 seconds East a distance of 56.86 feet to a 5/8" iron pin found; thence North 0 degrees 19 minutes 01 second East a distance of 851.36 feet to a 1-1/4" OD iron pipe found; thence leaving the east line of the City of Nelsonville South 89 degrees 29 minutes 51 seconds East a distance of 916.17 feet to a 5/8" iron pin set and being the point of **beginning** of the tract of land to be described;

thence with the center of State Route 78 the following six bearings and distances:

- 1) South 63 degrees 05 minutes 20 seconds West a distance of 96.38 feet to a point;
- 2) South 66 degrees 44 minutes 57 seconds West a distance of 104.96 feet to a point;
- 3) South 70 degrees 10 minutes 06 seconds West a distance of 174.94 feet to a point;
- 4) South 70 degrees 13 minutes 07 seconds West a distance of 173.60 feet to a point;
- 5) South 65 degrees 06 minutes 35 seconds West a distance of 103.54 feet to a point;
- 6) South 58 degrees 46 minutes 27 seconds West a distance of 28.27 feet to a PK nail set in the pavement of State Route 78;

thence leaving the center of State Route 78 North 12 degrees 58 minutes 07 seconds West a distance of 101.13 feet to a 5/8" iron pin set and passing a 5/8" iron pin set at a distance of 41.61 feet;

thence North 0 degrees 23 minutes 42 seconds West a distance of 38.69 feet to a 5/8" iron pin set; thence North 44 degrees 55 minutes 38 seconds East a distance of 159.42 feet to a 5/8" iron pin set; thence North 63 degrees 27 minutes 21 seconds East a distance of 119.91 feet to a 5/8" iron pin set; thence North 56 degrees 40 minute 09 seconds East a distance of 173.67 feet to a 5/8" iron pin set; thence North 20 degrees 15 minutes 54 seconds East a distance of 26.02 feet to the point of

beginning containing 3.042 acres more or less, subject to the public easement of State Route 78 and any other public or private easements of record.


