Being a "NEW SINGLE PARCEL LEGAL DESCRIPTION of a 0.253 Acre Combined Parcel" (as depicted on the herein included EXHIBIT "B") encompassing six (6) individual parcels owned by the Grantor herein, David A. Sagan, as recorded in the Athens County Recorder's Office, Athens County, Ohio, with all being situate in Section 24, Town-12-North, Range-15-West, Nelsonville City, York Township, Athens County, State of Ohio, USA, and consisting of the following six (6) parcels:



- Thence S 11°35'12" W along the West line of "Pine Grove Apartments" (OR.102/Pg.930) and the East property line of Douglas E. & Carmen J. Mitchell – Parcel Three - OR.470/Pg.653), 30.00 feet to an iron pipe found in August 2007 in one of the Southwesterly property corners of said "Pine Grove Apartments" (OR.102/Pg.930), and, also being in the Northwesterly corner of (OR.301/Pg.1139 - First Parcel)(Parcel (A) above) owned by the Grantor, David A. Sagan, herein, said iron pipe found also being the real POINT OF BEGINNING of described "NEW SINGLE PARCEL LEGAL DESCRIPTION of a 0.253 Acre Combined Parcel":
- Thence S 75°40'14" E along one of the said Grantor's (David A Sagan First Parcel -OR.301/Pg.1139)) (Parcel {A} above) existing Northerly property line and a Southwesterly property line of said "Pine Grove Apartments" (OR.102/Pg.930), 65.04 feet to an iron pin w/cap stamped "Seymour-PS6044) found in Aug. 2007 in the said Grantor's (David A Sagan - First Parcel - OR.301/Pg.1139) (Parcel {A} above) existing Northeasterly corner and another of the Southwesterly property corners of said "Pine Grove Apartments" (OR.102/Pg.930);
- Thence S 12°04'23" W, along one of the said Grantor's (David A Sagan First Parcel -OR.301/Pg.1139) (Parcel {A} above) existing Easterly property lines and another Southwesterly property line of said "Pine Grove Apartments" (OR.102/Pg.930), 81.82 feet to an iron pin w/cap set by me in August 2007 in the said Grantor's (David A Sagan - First Parcel - OR.301/Pg.1139) (Parcel {A} above) existing Southeasterly corner and another of the Southwesterly property corners of said "Pine Grove Apartments" (OR.102/Pg.930), said iron pin set also being in the Northeasterly corner of said Grantor's (David A Sagan - OR.301/Pg.1139) owned portion of a Vacated 16.0' Alley - ORD.NO.17-72 (Parcel {E} above);
- Thence S 10°45'25" W, along the East line of said Grantor's (David A Sagan OR.301/Pg.1139) owned portion of a Vacated 16.0' Alley - ORD.NO.17-72 (Parcel {E} above) and the West line of a 16.0' Unimproved Alley R/W that has not been vacated to date, 16.03 feet to an iron pin w/cap set by me in August 2007 in the Southeasterly corner of said Grantor's (David A Sagan - OR.301/Pg.1139) owned portion of a Vacated 16.0' Alley - ORD.NO.17-72 (Parcel {E} above), the Northwesterly corner of said Grantor's (David A Sagan -

OR.301/Pg.1139) owned West-1/2 of Vacated 16.0' Alley - ORD.NO.11-70 (Parcel {D} above), and, the Northeasterly corner of said Grantor's (David A Sagan - Parcel III - OR.301/Pg.1139)(Parcel {C} above);

- 7) Thence S 75°40'00" E, along the North line of said Grantor's (David A Sagan OR.301/Pg.1139) West-1/2 of Vacated 16.0' Alley ORD.NO.11-70 (Parcel {D} above) and the South line of said 16.0' Unimproved Alley R/W that has not been vacated to date, 8.00 feet to an iron pin w/cap set by me in August 2007 in the Northeasterly corner of said Grantor's (David A Sagan OR.301/Pg.1139) owned West-1/2 of Vacated 16.0' Alley ORD.NO.11-70 (Parcel {D} above);
- 7 Thence S 14°23'02" W, along the East line of said Grantor's (David A Sagan OR.301/Pg.1139) West-1/2 of Vacated 16.0' Alley ORD.NO.11-70 (Parcel {D} above), 97.91 feet to an iron pin w/cap set by me in August 2007 in the Southeasterly corner of said Grantor's (David A Sagan OR.301/Pg.1139) owned West-1/2 of Vacated 16.0' Alley ORD.NO.11-70 (Parcel {D} above) and the existing Easterly R/W line of Pine Grove Drive;
- Thence the following six (6) courses along the said Grantor's (D.A. Sagan) (OR.301/1139-1st 5 courses) & (OR.505/415-6th course) Westerly property lines and the said existing Easterly R/W line of Pine Grove Dr.:
 - 1) N 13°29'57" W, 17.10 feet to an iron pin w/cap set by me in August 2007 in the Southwesterly corner of said Grantor's (David A Sagan OR.301/Pg.1139) owned West-1/2 of Vacated 16.0' Alley ORD.NO.11-70 (Parcel {D} above) and the Southeasterly corner of said Grantor's (David A Sagan Parcel III OR.301/Pg.1139)(Parcel {C} above);
 - N 20°31'18" W, 15.37 feet to a drill hole set in the top of a concrete curb by me in Aug.'07;
 - 3) N 18°22'32" W, 83.40 feet to a drill hole set in the top of a concrete curb by me in Aug.'07 in the Northwesterly corner of said Grantor's (David A Sagan Parcel III OR.301/Pg.1139)(Parcel {C} above) and the Southwesterly corner of said Grantor's (David A Sagan OR.301/Pg.1139) owned portion of a Vacated 16.0' Alley ORD.NO.17-72 (Parcel {E} above);
 - 4) N 18°39'55" W, 19.08 feet to a drill hole set in the top of a concrete curb by me in Aug.'07 in the Northwesterly corner of said Grantor's (David A Sagan OR.301/Pg.1139) owned portion of a Vacated 16.0' Alley ORD.NO.17-72 (Parcel {E} above) and also being in the South line of said Grantor's (David A Sagan First Parcel OR.301/Pg.1139) (Parcel {A} above);
 - N 18°57'34" W, 68.35 feet to a drill hole set in the top of a concrete curb by me in Aug.'07 in the Northwesterly corner of said Grantor's (David A Sagan Parcel II OR.301/Pg.1139)(Parcel {B} above) and the Southwesterly corner of said Grantor's (David A Sagan OR.505/Pg.415)(Parcel {F} above), said drill hole set being witnessed by an iron pin found by me in Aug.'07 that bears: S 82°42'03"E, 2.11 feet FROM said drill hole set, and;
- 6) N 21°51'28" W, 23.00 feet to an iron pin w/cap set, between the edge of pavement and the face of curb, by me in Aug.'07 in the Northwesterly corner of said Grantor's (David A Sagan OR.505/Pg.415) (Parcel {F} above) and the Southwesterly corner of property owned by said Douglas E. & Carmen J. Mitchell (OR.470/Pg.653 Parcel Three Residue);
- 10) Thence S 83°08'51" E, along the Grantor's (David A Sagan OR.505/Pg.415) (Parcel {F} above) North property line and the South property line of said Douglas E. & Carmen J. Mitchell (OR.470/Pg.653 Parcel Three Residue), 46.54 feet to the point of beginning, and containing a total of 0.253 acre.
- 11) The bearings used in the above description are based on the North Line of Franklin Street (66.0' R/W) as bearing: N 75°40'00" W, and, are only for the determination of relative angles.
- Subject to all legal highways and easements.
- All iron pins w/cap set referred to in the description above are 5/8" x 30" iron pins with 1-3/8" diameter plastic I.D. caps stamped "G.W. BAYHA P.S.6139 740.593.5686".
- The above described "NEW SINGLE PARCEL LEGAL DESCRIPTION of a 0.253 Acre Combined Parcel" was surveyed by Gerald W.
