Beginning at a point in Township Road No. 276, said point being the true point of beginning and by prior description, recorded in Deed Volume 344, page 639, being South eighty-seven (87) degrees forty-four (44) minutes East sixty and one tenth (60.10) feet; South twenty-one (21) degrees zero (00) minutes West one hundred seventy-four and three tenths (174.30) feet; South sixteen (16) degrees thirty-five (35) minutes West one hundred fifty-one and eight tenths (151.80) feet; South fifty (50) degrees thirty (30) minutes West seventy-six and fifty-four hundredths (76.54) feet; North eighty-one (81) degrees thirty (30) minutes sixty-one and seventeen hundredths (61.17) feet; North fifty-two (52) degrees ten (10) minutes West three hundred seventy-eight and seven tenths (378.70) feet; North sixty-five (65) degrees thirty-six (36) minutes West three hundred one and eighty-seven hundredths (301.87) feet; North fifty-one (51) degrees zero (00) minutes West twenty-seven and sixty-three hundredths (27.63) feet from a stone on the south line of Fraction Eight (8), said stone being the northwest corner of the south half of the northeast quarter of Section Thirty-three (33); thence, continuing along the centerline of said Township Road, North fifty-one (51) degrees zero (00) minutes West a distance of two hundred seventy-six and fifteen hundredths (276.15) feet to a point; thence, North fifty-one (51) degrees forty-six (46) minutes West a distance of three hundred fifty-eight and eighty-nine hundredths (358.89) feet to a point; thence, North twentyseven (27) degrees twenty-eight (28) minutes West a distance of thirtythree and thirty-two hundredths (33.32) feet to a point; thence, leaving said Township Road South eighty-six (86) degrees thirty (30) minutes East, passing an iron pipe found at fifty and fifty-eight hundredths (50.58) feet, a distance of five hundred ninety-one and two tenths (591.20) feet to an iron pipe found; thence, South eleven (11) degrees twenty-one (21) minutes twenty-seven (27) seconds West, passing through an iron pin set at three hundred sixty-three and twenty-eight hundredths (363.28) feet, a distance of three hundred ninety-seven and fourteen hundredths (397.14) feet to the true point of beginning.

Containing two and seven hundred fifty-three thousandths (2.753) acres of which one thousandths (0.001) acre is in Fraction Thirty-two (32) and two and seven hundred fifty-two thousandths (2.752) acres are in Fraction Eighty (8).

Subject to all reservations, right-of-ways, leases and easements of record.

The basis for bearings in the above description was assuming a bearing of South eighty-seven (87) degrees forty-four (44) minutes East for the south line of Fraction Eight (8).
