Commencing for reference at a stone found at the Northeast corner of Section 3, Starr Township, Hocking County which is the West line of Athens County; thence with the Athens - Hocking County line South 0 degrees 10 minutes 01 second West a distance of 1153.94 feet to a 5/8" iron pin previously set on the west line of Section 33, York Township, Athens County; and being the point of **Beginning** of the tract of land to be described;

thence leaving the West line of Section 33 North 88 degrees 44 minutes 17 seconds East a distance of 162.37 feet to a 5/8" iron pin set;

thence South 2 degrees 31 minutes 58 seconds East a distance of 1133.01 feet to a 5/8" iron pin set in the center of Township Road 275 and passing 5/8" iron pins set at distances of 975.81 feet and 1121.01 feet;

thence with the center of Township Road 275 the following two bearings and distances:

- 1) South 76 degrees 45 minutes 02 seconds West a distance of 154.63 feet to a 5/8" iron pin previously set;
- 2) South 83 degrees 53 minutes 49 seconds West a distance of 65.67 feet to a damaged 5/8" iron pin found on the West line of Section 33;

thence leaving the center of Township Road 275 and with the West line of Section 33 North 0 degrees 10 minutes 01 second East a distance of 1170.75 feet to the point of beginning, passing a 5/8" iron pin set at a distance of 20.00 feet and passing a 5/8" iron pin found 1.35 feet West of line at a distance of 346.21 feet, containing 5.024 acres more or less and subject to the public easement of Township Road 275 and any other public or private easements of record.


