Commencing for reference at a wood post found at a point taken to be the Southwest corner of Section 33; thence with the South line of Section 33 South 89 degrees 12 minutes 09 seconds East a distance of 3782.27 feet to a 5/8" iron pin previously set; thence leaving the South line of Section 33 North 0 degrees 12 minutes 09 seconds West a distance of 1043.09 feet to a 5/8" iron pin previously set; thence North 44 degrees 56 minutes 10 seconds West a distance of 1124.38 feet to a 5/8" iron pin set and being the point of **Beginning** of the tract of land to be described;

thence continuing North 44 degrees 56 minutes 10 seconds West a distance of 175.09 feet to a 5/8" iron pin set;

thence North 39 degrees 00 minutes 00 seconds East a distance of 1254.53 feet to a PK nail set in the surface of Township Road 276 and passing 5/8" iron pins set at distances of 977.79 feet and 1234.53 feet;

thence with the surface of Township Road 276 the following two bearings and distances:

 - 2) South 49 degrees 05 minutes 48 seconds East a distance of 29.40 feet to a PK nail set;

thence leaving the surface of Township Road 276 South 39 degrees 00 minutes 00 seconds West a distance of 1254.96 feet to the point of beginning, passing 5/8" iron pins set at distances of 18.00 feet and 266.42 feet, containing 5.011 acres more or less, and subject to the public easement of Township Road 276 and any other public or private easements of record.


