Commencing for reference at a wood post found at a point taken to be the Southwest corner of Section 33; thence with the South line of Section 33 South 89 degrees 12 minutes 09 seconds East a distance of 3782.27 feet to a 5/8" iron pin previously set; thence leaving the South line of Section 33 North 0 degrees 12 minutes 09 seconds West a distance of 1043.09 feet to a 5/8" iron pin previously set; thence North 44 degrees 56 minutes 10 seconds West a distance of 2148.87 feet to a 5/8" iron pin set and being the point of **Beginning** of the tract of land to be described;

thence continuing North 44 degrees 56 minutes 10 seconds West a distance of 200.18 feet to a 5/8" iron pin previously set;

thence North 37 degrees 17 minutes 00 seconds East a distance of 1172.17 feet to a PK nail previously set in the surface of Township Road 276 and passing 5/8" iron pins set at distances of 235.85 feet, 923.69 feet, and 1152.17 feet;

thence with the surface of Township Road 276 the following two bearings and distances:

- 1) South 56 degrees 07 minutes 52 seconds East a distance of 72.57 feet to a 5/8" iron pin previously set;
- 2) South 54 degrees 08 minutes 17 seconds East a distance of 96.01 feet to a 5/8" iron pin previously set:

thence leaving the surface of Township Road 276 South 35 degrees 51 minutes 43 seconds West a distance of 1206.35 feet to the point of beginning, passing 5/8" iron pins set at distances of 18.00 feet and 287.70 feet, containing 5.005 acres more or less, and subject to the public easement of Township Road 276 and any other public or private easements of record.

The above 5.005 acre survey is intended to describe part of the tracts as deeded to Larry P. Gerstner, deed references Volume OR256, Page 679, and Volume OR257, Page 753, both of the Athens County Recorder's Office. 
