LOCATION: On York Twp. Road No. 279.

Situate in River Lct 659, Section 36, Town 12, Range 15, York Township, Athens County, State of Ohio and being more particularly described as follows:

Commencing at a stone in the intersection of the center of the Old Hocking Canal Tow Path and the East line of Section 36; thence N 0° E along the said East line of Section 36, 283.70 feet to an iron pin in the Northerly Right-Of-Way line of U.S. Route No. 33 as it is now located; thence S 59° W along a line, 1,128.36 feet to an iron pin; thence S 04°15' W along a line, 421.93 feet to an iron pin; thence N 35°51' W along a line, 151.42 feet to a point; thence S 77°52' W along a line, 47.40 feet to an iron pin; thence S 35°28' W along a line, 170.70 feet to an iron axle set in the most Easterly corner of a 0.59 acre tract owned by Robert B. and Betty L. Davis; thence S 04°19' W along the said 0.59 acre (Davis) tract's Southeasterly line, 143.20 feet to a 3/4" iron bar found in the most Southerly corner of said 0.59 acre (Davis) tract, said 3/4" iron bar also being the real point of beginning of the parcel herein described:

Thence S 55°34'49" W along a random line, 292.13 feet to an iron pipe set; thence N 15°09'00" E along a random line, 271.25 feet to an iron pipe set in the most Westerly corner of said 0.59 acre (Davis) tract, said iron pipe set being witnessed by an iron pipe found, that is incorrect because of a landslip, that bears S 48°07'19" W, 0.32 feet from the iron pipe set at the true corner; thence S 60°23'00" E along the Southwesterly line of said 0.59 acre (Davis) tract, 195.66 feet to the point of beginning and containing 0.5898 acre.

Subject to all legal, highways and easements of record.


