## DESCRIPTION OF A 0.340 ACRE PARCEL

## Situated in York Township, Athens County, State of Ohio

Being a **0.340** acre parcel of land located in the Columbus and Hocking Coal and Iron Company's First Addition to Buchtel as shown by the plat thereof recorded in Enevelope 145A of the records of the Athens County Recorder, Section 6, Township 12 North, Range 15 West, York Township, Athens County, State of Ohio and being a combination of Lot 393 and a portion of a vacated street as conveyed to Beaver Excavating Company by a deed recorded in Official Records Book 442 at Page 41 of said county Deed Records and being designated as Parcel P020020000100 and Parcel P020020000101 by the said county Auditor, and being more fully bounded and described as follows:

Beginning at the Northwesterly corner of said Lot 393;

- Course No. 1 Thence, N 25° 15' 00" E, with the projection of the westerly line of said Lot 393, being the basis of bearings for this description, 20.15 feet to an iron pin (set), being a point in the center of a vacated street;
- Course No. 2 Thence, S 71° 45′ 00" E, with said centerline and parallel with the northerly line of said Lot 393, 207.55 feet to an iron pin (set), being a point in the northwesterly right of way line of State Route 78, a variable width right of way, as shown by the plans of the Ohio Department of Transportation Project ATH-78-1;
- Course No. 3 Thence, S 64° 24' 00" W, with said right of way line and the easterly line of said Lot 393, 71.13 feet to an iron pin (set);
- Course No. 4 Thence, S 47° 32' 30" W, with said lines, 34.48 feet to an iron pin (set);

- Course No. 5 Thence, N 76° 53' 57" W, with the northerly line of Marietta Avenue, formerly State Route 216, the right of way of said State Route 78, 151.40 feet to an iron pin (set), being the southwesterly corner of said Lot 393 and a point in the easterly line of Franklin Street, a 40 foot platted street;
- Course No. 6 Thence, N 25° 15' 00" E, with the westerly line of said Lot 393 and the easterly line of said street, 73.49 feet to the Point of Beginning, containing **0.340** acre, more or less, being subject to all legal right of ways, easements, reservations and restrictions of record.

All iron pins set being 5/8" x 30" rebar with plastic cap stamped "Snyder PS6651".




