Commencing at a found iron pin at the southeast corner of a 0.67 acre tract owned by Thomas W. Wallace and described in Volume 116 Page 339 of the Athens County Deed Records, said found iron pin is also THE TRUE POINT OF BEGINNING; thence along the north property line of a tract described in Volume 365 Page 259 of the Athens County Deed Records South 40°17'00" West 175.34 feet to a found iron pin; thence North 10°01'02" West 90.01 feet to a set iron pin on the south property line of aforesaid 0.67 acre tract; thence along the south line North 70°43' 34" East 136.68 feet to the point of beginning containing 0.1394 acres and being a part of a tract described in Volume 223 Page 49 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.
