BEGINNING at a point that bears North 37°43'09"East, 18.43 feet from the Northeast corner of Lot 65,

THENCE North 37°43'09"East, 66.58 feet to a point,

THENCE along the line of Grandy (406-787 OR) the following two courses:

- 1) North 46°50'48"East, 115.66 feet to an iron pin set,
- 2) North 42°14'31"East, 70.93 feet to a point,

THENCE along a curve to the left having a radius of 298.37 feet and a chord that bears North 34°54'12"East, 74.29 feet to an iron pin found,

THENCE along the line of Lewis (417-97 OR) North 89°52'02"East, 67.87 feet to an iron pin found,

THENCE along Fork St. South 27°37'32"West, 31.84 feet to a point,

THENCE along a curve to the right having a radius of 358.37 feet and a chord that bears South 35°00'26"West, 89.34 feet to a point,

THENCE along the line of Dupler (448-2160 OR), South 42°14'30"West, 257.29 feet to a point, (passing an iron pin set at 70.94 feet),

THENCE along a curve to the right that has a radius of 687.39 and a chord that bears South 44°59'50"West, 66.09 feet to an iron pin set,

THENCE North 1°33'42"East, 93.27 feet to the point of beginning, (passing an iron pin set at 87.08 feet) and containing 0.558 acres of which 0.023 acres is out of Tract 1 of OR 448-2160 and 0.535 acres is out of Tract 3 of OR 448-2160.

BEGINNING at an iron pin that bears North 37°43'09"East, 18.43 feet, thence South 1°33'42"West, 93.27 feet from the Northeast corner of Lot 65,

THENCE North 1°33'42"East, 40.00 feet to a point,

THENCE South 48°56'57" East, 28.36 feet to a point,

THENCE along a curve to the right having a radius of 687.39 feet and a chord that bears South 46°27'27"West, 31.01 feet to the point of beginning and containing 0.010 acres.
