The basis for bearings in the above description was assuming a bearing of South 88 degrees 26 minutes 18 seconds East for the north line of Lot No. 97.


The above description was prepared from an actual survey of the premises made by Joseph C. Roman, Registered Surveyor No. s6461, in June and July 1997.
