BEGINNING, FOR REFERENCE, AT THE SOUTHWEST CORNER OF THE SOUTHWEST CORNER OF SECTION 7:

THENCE WITH THE SOUTH LINE OF SECTION 7, S 89°45'16" E 565.85 FEET TO AN IRON PIN FOUND MARKING THE SOUTHEAST CORNER OF THE HANNING TRACT;

THENCE LEAVING SAID SECTION LINE WITH THE EAST LINE OF THE HANNING TRACT, N 00°46'00" E 2222.09 FEET TO AN IRON PIN FOUND;

THENCE CONTINUING WITH THE EAST LINE OF THE HANNING TRACT N 13°47'00" E 419.99 FEET TO A POINT IN THE CENTERLINE OF COUNTY ROAD # 268;

THENCE WITH THE CENTERLINE OF COUNTY ROAD 268 N 69°24'10" W 25.18 FEET TO A POINT AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED;

THENCE WITH A NEW LINE THROUGH THE HANNING TRACT S 13°47'00" W 422.98 FEET TO A POINT;




