- 2. North 51°31'33" East, 447.29 feet to the point of beginning and containing 5.100 acres of which 3.351 acres is in River Lot 622 and 1.749 acres is in River Lot 623.

Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed Stevens, PS 8716.
